

In this case please refer to the inspection report issued U/No-FB/CELL/01 Dated— 03.11.2014 to the existing school namely Orchids, The International School, managed by Shree C. V. O. D. Jain Pathshala Trust, situated at 84, Samuel Street, - Hazrat Abbas Street (Palagaly), Mumbai 400 009.

Now the Principal Mrs. Beena Nayaken of Orchids, The International School (Shree C. V. O. D. Jain Pathshala Trust), vide his letter dated 24.06.2016 has reported the compliance of the requirements stipulated vide this office NOC U/no-FB/CELL/01 Dated—03.11.2014, to the existing school in the above said premises and requested for the compliance certificate in respect of the same to occupy & use the premises. The party has also submitted the 'A' Form issued by M/s Vaishali Fire System Ltd, (Regn No-MFS / LA / RD / 0102 & MFS / LA / RF 0131). However the party has given hardship that since this is an existing building and already occupied and hence sprinkler system cannot be installed in the school at this stage and hence condition no-45 from the said fire safety requirements is not fulfilled, however instead the party has provided down-comer system and also provided fire service inlet.

On receipt of the letter from the Principal of the School, a senior officer of this Department visited the premises to verify and ensure the compliance of the requirements stipulated by this department U/no-FB/CELL/01 Dated—03.11.2014. It was observed during the inspection that the party has complied with all the requirements stipulated by this department U/no-FB/CELL/01 Dated—03.11.2014 except condition no-45 (sprinkler system) as this is an existing building and there is no space for the fire-fighting tank at ground level for the sprinkler system and has provided down-comer system instead of dry-riser system as mentioned in condition no-46.

In view of above and as far as this department is concerned, there would be no objection to allow the party to occupy & use the Orchids, The International School (Shree C. V. O. D. Jain Pathshala Trust), 84, Samuel Street, Mumbai – 400 009. However it shall be the duty and responsibility of the occupiers to observe the fire safety measures and maintain the fire-fighting system in good working order all the times.
